Focus on Energy requires a site assessment when you apply for a wind energy installation incentive, and site assessments are recommended for customers considering installing a solar system.

SITE ASSESSMENT STEPS

1. Contact a qualified site assessor to schedule and perform your assessment. Visit focusonenergy.com/siteassessments for a directory of Focus on Energy recognized site assessor certifications and assessor listings.
2. Following the completion of your site assessment, complete and email or mail a signed copy of this application and itemized invoice to the address indicated at the bottom of the page. A copy of the site assessment report is also required for wind site assessments.
3. The incentive payment may be made payable to either the customer or the site assessor. If it is made payable to the site assessor, the customer must be credited the amount of the incentive by the site assessor, and that credit must be clearly labeled on the invoice that is submitted with the application.
4. Site assessment incentive payments will be made within 6-8 weeks after the completed site assessment paperwork is submitted and approved.

SITE ASSESSMENT REQUIREMENTS

- Solar Electric Site Assessment Eligibility:** A solar electric site assessment must be performed at a job site whose owner purchases electricity from an electric provider participating with Focus on Energy for that job site.
- Solar Water Heating Site Assessment Eligibility:** A solar water heating site assessment must be performed at a job site whose owner purchases natural gas from a participating natural gas provider for that job site (if the primary water heating fuel type is natural gas) or purchases electricity from a participating electric provider for that job site (if the primary water heating fuel is electricity).
- Wind Electric Site Assessment Eligibility:** A wind electric site assessment must be performed at a job site whose owner purchases electricity from an electric provider participating with Focus on Energy for that job site.
- Qualified Site Assessor:** A site assessor must be certified by a Focus on Energy recognized site assessor certification body. Visit focusonenergy.com/siteassessments for a directory of Focus recognized certifications and assessor listings.
